## MOVING IN & OUT

### Room Assignments - at the start of the school year

Dorm rooms and beds are assigned to boarding students by Residential Staff. Once assigned, students must sleep in their designated room and bed for the remainder of the school year.

### Room Changes

If students wish to make changes to their room assignment at the start of the school year, they should present the reason for the change request to the residential staff of the dorm for approval. Change requests will be considered and can be denied. Northern reserves the right to make decisions and adjustments to change room assignments of students as needed, should the necessity arise.

### Moving In - Start of School

#### **Move-in Dates/Times:**

***New & Returning Boarding Students (and their returning siblings):*** Will move in Saturday, August 15, 2026 from 2:00PM-9:00PM

**Mandatory Dorm orientation** for boarding students: Sunday, August 16, 2026 from 1:00PM-5:00PM.

New & Returning student school orientation: Monday, August 17th, starting at 9:00am  
First Day of Classes for all students: Tuesday, August 18th, starting 7:55am

**IMPORTANT:** Northern Academy's residential dorms are **not available** anytime prior to the dates and times specified above. Please make your travel arrangements accordingly!

As soon as you make your travel plans:

- parents of returning students should email [dorm@northernacademy.org](mailto:dorm@northernacademy.org) to confirm the intended moving-in and out dates.

**Winter Break Dorm Closure starts-** Saturday December 19th 2026, at 9pm

- **Boarding student return to dorms-** January 3rd 2026, at 2pm-9pm
- **Spring Semester classes start-** Monday, January 4th, 7:55am for all students.

Winter Break for Northern Academy coincides with the celebrations of the various religious and cultural Winter and New Year's holidays in the United States, and are an important time for families to gather and spend time together. All academic and residential staff are granted leave and thus, academic classes and Dormitory facilities are closed for the duration of Winter Break.

All boarding students are to vacate dorms by **9pm, Saturday, December 19th 2025**. We advise families to make travel arrangements for their child as early as possible. Students may keep their personal items in their dorm room while they are away and valuables should be secured in a locked locker. Rooms are to be left clean and in good order and will

**Moving Out - End of School Year - Sunday May 30th, 2027 by 9pm**

At the end of the school year, all students will move out of the dormitory rooms. Students are expected to return the room to the same condition as they first received it. Each room will be inspected for damages to the basic furnishings, walls, windows, and structural fixtures. Any damages beyond normal usage will incur charges billable to parents to cover cost of repairs and/or replacement.

Any needed cleanup of the room by Residential Staff will incur a cleaning fee billable to parents.

**Move-out Procedure:**

1. Prior to end-of-year move out date, students will:
  - a. start to pack up belongings, determining what they will keep and discard.
  - b. return school issued Chromebooks, phones, textbooks, library books, calculators
  - c. empty lockers

- d. prepare passport/visa
  - e. close custodial bank accounts - balance must be at 0 prior to closing
  - f. non-returning students must fill out a post office card for mail forwarding.
2. On move-out day, the dorm room must be completely vacated of all belongings. Any belongings not removed will be considered as abandoned and discarded.
  - a. all bedding stripped from mattress,
  - b. all closets and drawers emptied,
  - c. all trashed bagged and discarded,
  - d. clean out food from refrigerator, shoe rack, bathrooms
  - e. entire room broom-swept including closets and under beds
3. Students are expected to return the room in the same condition as they received it, any needed cleanup of the room by Residential Staff will incur a cleaning fee billable to parents.

### **Storage of Personal Belongings:**

Limited storage is available for returning students over the Summer break. Only students who have been accepted for readmission will be allowed to store personal belongings in designated dorm storage areas, as space allows.

Students will initiate communications with residential staff about Summer storage of personal belongings, if needed.

## **RESIDENTIAL SERVICES**

Northern Academy provides limited on-campus dorm facilities and amenities. Our residential services include supervision, meals, facilities for laundry, transportation for alternate weekend shopping trips. Residential staff oversee students in biological-gender segregated facilities.

### **Facilities and Amenities**

Dorm facilities include rooms that host 2 to 4 students. Each dormitory provides basic furnishings for residential living -- each student is provided a bed, desk, chair, a set of drawers and either closet space or a free-standing clothing rack. Storage is very limited. If personal belongings go beyond provided storage availability, students will purchase organizers and storage containers as needed at their own expense.

Shared appliances include washers and dryers, refrigerators, microwave ovens, and filtered water dispensers. As Northern dorms have limited pantry space, in-dorm cooking is restricted to warming foods in a microwave and boiling water. Purchased snacks must be stored in sealed containers to not attract bugs and mice. Eating in bedrooms is not allowed.

Students will have all major meals provided in the school cafeteria.

Each bathroom is provided with toilet paper, hand soap and hand towels.

### **Life Skills Training**

Boarding students are trained for life skills including maintaining personal hygiene, organization, and time management, as needed. Our Northern Academy school counselor and school nurse provide lessons for students addressing physical and mental health, hygiene and personal space issues. All residential

students are expected to fully self regulate and be willing to develop, or improve on, good self care skills and habits, as well as good interpersonal skills and habits.

## Mail and Packages

### Shipping Packages

Each dormitory house has a mailbox for letters and a secured dropbox for parcels. Parents and students must not purchase or ship materials that violate existing school policies, e.g. smartphones and other devices. Northern reserves the right to hold packages and request students open them in the presence of dormitory and/or administrative staff, to ensure compliance with this requirement.

- Packages may be shipped directly to the dormitory in which your child resides.
- It is the responsibility of the student and family to ensure that each mailed item has an accurate address and the correct full name of the student - no nicknames or abbreviations.
- Northern Academy is not responsible for any lost mail and packages. Any claims should be directed to the responsible carrier and/or merchant.

## School Vans and Bus

Students will enjoy shopping trips and recreational activities that are in abundance in the Hudson Valley area. School vans, minivans and school bus provide the means by which students are able to participate in the organized school trips. These vehicles are the means by which school staff will transport students to off campus medical appointments, as necessary.

### Student behavior expectations while traveling

All students will follow these behavior expectations across when riding in school vehicles:

- Do not distract the driver! The driver needs to see and hear what's around the vehicle to keep everyone safe.
- Front passenger seats are reserved for the adult chaperones who will assist the driver to navigate, and maintain order in the vehicle.
- Stay in your seat with seatbelts fastened when the vehicle is moving, as required by [NY Occupant Restraint Law](#). If a student is non-compliant in wearing a seatbelt and should the driver be pulled over by State law enforcement and issued a monetary fine, the parent will be billed for payment.
- Headphone use to enjoy music.

- Follow the driver’s directions, including when you can get into and out of the vehicle.
- No eating or drinking in any vehicle. Remove all trash and personal items when you leave the vehicle, unless the driver requests otherwise.

Violating this policy can result in loss of travel privileges and other consequences.

## HEALTH & SAFETY REGULATIONS

### Feeling unwell

All residential students are required to have health insurance which covers hospitalization as a condition of acceptance into the dorms. By signing the Enrollment Consent & Required Documents form, parents give the school permission to seek medical treatment for their child when staff determines it to be necessary. Should an emergency arise, Residential Staff will accompany the student to Urgent Care or Emergency at Garnet Medical Center.

Residential Staff are not trained medical professionals, and will defer all health-related decisions to the School Nurse. It is the student’s responsibility to inform parents about illness and injury. However, for significant illnesses and injuries, the School Nurse will contact parents. Boarding students must attend off-campus immunization and medical appointments as deemed necessary. Our School Nurse can make appointments for students to receive medical care, as needed..

Any students who feel unwell and exhibit symptoms should refrain from attending any class, co-curricular activities, etc. Students must consult with the School Nurse for a proper evaluation when they feel unwell.

### **Students who feel unwell in dorms must follow this procedure:**

#### **Feeling unwell before School Starts, Mon-Fri:**

Residential students will not be allowed to stay in the dorms during the school day when feeling unwell.

1. Before dorm leaving time, the student must discuss their symptoms and concerns with residential staff.
2. By 9:00am, the student will report to the nurse for evaluation and may be allowed to rest in the infirmary. Students will take their uniform, school materials, Chromebook and communication device with them to the infirmary.

#### **Feeling unwell During School hours:**

Residential students are not allowed to return to the dorms during the school day, even if feeling unwell.

1. The student must promptly discuss their symptoms and concerns with their classroom teacher.
2. The student must report to the nurse for evaluation and may be able to rest in the infirmary for a limited period of time.

#### **Feeling unwell After School hours / weekends / snowdays / holidays:**

Students are to inform residential staff on duty of any health concerns, and may rest in the dormitory. Residential staff will consult with the school nurse about a plan of action. Should the necessity arise that a student needs to be taken to an off-campus medical facility, transport fees will apply.

## Taking Medication

Northern Academy dormitories follow New York State law which requires that all medications, including prescription and nonprescription over-the-counter (OTC) medicines, be administered to students on campus only with express written permission from both a healthcare provider and the student's parents. Please refer to Exhibit D1, D2 below for the required forms.

The medication, the reason for use, dosage, frequency, method of administration and possible side effects must be recorded by our school nurse. Parents must appoint a designee to administer the medication to the student at school and the dormitory. The designee must be trained in the administration of the medication. All medications will be held in locked storage to ensure that medications are being used safely, prevent overuse and misuse, and prevent other students, who live in the dormitory, from misusing the medication. Students may not buy OTC medications on their own and medication cannot be held by minor children in their rooms. All students who have OTC medications must present the medications to the school nurse.

The following OTC medications are NOT allowed in the dorms:

- All sleep aids, including the supplement Melatonin,
- All fever-reducing (anti-pyretic) medications that are also used to treat pain and inflammation, including:
  - Ibuprofen (Advil, Motrin, etc)
  - Naproxen (Aleve)
  - Aspirin (Bayer, Excedrin, etc.)
  - Acetaminophen (Tylenol)
  - Medications that contain any of these fever-reducer/pain-relievers as an ingredient (NyQuil, Robitussin, Dimetapp, etc)
- All cough suppressants and other medications used to alleviate cold symptoms
- As-needed antihistamines (Claritin, Zyrtec, Allegra, etc.)

Students requiring daily antihistamines for documented allergies may keep these medications in the dorm with the proper completed paperwork.

Students who require medications for respiratory rescue, allergies, or diabetes will be permitted to carry and self-administer their medications with the proper completed paperwork completed by a healthcare provider order authorizing them to carry and self-administer their medications and written parent/guardian consent pursuant to Education Law §§ 916, 916-a, and 916-b. source <https://www.schoolhealthny.com/Page/242>

## Fire Drills & Safety Drills

As part of the safety plan of Northern Academy, Fire Drills and Emergency Response procedures are practiced by all members of the campus throughout the year. Students will regard all drills with utmost seriousness as these practice drills will ensure that all persons will be safe and accounted for if a real emergency arises. Students are expected to do the following:

- When the alarm is triggered, all students and residential staff are to immediately exit the building in a calm orderly fashion, and quietly walk to designated areas to await instruction from residential staff and/or emergency drill personnel.
- All names will be checked by residential staff to ensure complete evacuation and that all residents are accounted for.
- Any student absent from the name check will be reported to the Residential Director and/or emergency drill personnel on site.
- Students and staff may return to the dorm only when the all-clear signal is issued.

Evacuation procedure notices and maps are displayed in prominent positions in the dorm and throughout all campus buildings. Students should familiarize themselves with these maps.

# BEHAVIOR EXPECTATIONS

## Consideration for Others

The thought of “considering others first” creates a compassionate environment conducive to an enjoyable and uplifting educational experience. This is the foundation of a pleasant living environment and requires cooperation from all.

## Curfew and Quiet Time

- Middle school students must return to the dorms by 8:30pm curfew.
- High school students must return to the dorms by 9:30 pm curfew.

To ensure adequate rest, each dormitory observes designated Quiet time. When Quiet time begins, students may no longer visit other students’ rooms and must remain in their own rooms for the evening. During Quiet Hours, students may use common areas quietly for essential routines, such as brushing teeth, completing homework, or preparing for bed. Lights-Out is the designated time when all overhead bedroom lights must be turned off in preparation for sleep.

Students should take extra care to avoid making noise during quiet time. Phone calls and online communication must stop when quiet time begins. Residential staff will adjust the quiet time schedules as needed.

Students are expected to follow their dormitory schedule at all times. Any school-related activity that results in a return after curfew must be supervised by school staff. The supervising staff member must notify the Residential Team **at least 24 hours in advance**, providing the date of the activity, the expected return time, and the staff member’s name and contact information.

## Bedrooms - Cleanliness

All boarding students are expected to maintain their dorm room and personal belongings in a neat clean and orderly condition **at all times**. Residential Staff reserves the right to conduct room inspections both scheduled and unannounced “pop” inspections. Room and furniture must be clean and in good condition, the floor regularly broom swept, mopped and free of debris, garbage and clutter.

Health and hygiene are paramount; and students maintaining their bedroom is the foundation.

Any need for cleanup of any room by Residential Staff will incur a cleaning fee billable to parents.

## Bedrooms - Wall Hangings and Decorations

Residential students may decorate and add personal touches to their rooms, however such decorative displays must be in good taste and of a positive message.

- Decorations that display vulgar, violent, immoral, demonic or political language and/or images are not allowed, even in private rooms.
- Tape or fasteners used must not mar the paint nor damage the wall when removed.
- No double sided foam nor permanent tape is allowed on walls, bed frames or room furnishing.
- No permanent hooks or nails are allowed.
- Use removable, easily cleanable fastenings only. Command Brand offers a line of wall hanger materials that are acceptable for school use.

- Damage to walls, paint and furnishing will be billable to parents for cost of cleaning and or repair.

## Common Areas

Students will be assigned to take turns to clean common areas on a regular schedule. They will:

- Remove personal items from bathrooms and all common areas
- Maintain shared games, puzzles, etc.. in good condition for shared use and enjoyment.
- Clean bathroom sinks, mirrors and toilets
- Clean kitchen counters, sinks, and refrigerators
- Take out garbage
- Dust surfaces
- Vacuum and mop floors.

## RULES AND REGULATIONS

Northern Academy will conduct inspection of dorm rooms, lockers, backpacks, coats, personal belongings, etc., to verify compliance with school rules and regulations, Inspections may be scheduled and/or unannounced.

### General Dorm Rules

We are all here for a healthy shared living space. Here are basic expectations shared across the Northern Academy residences – most explain themselves. Each residence has additional rules specific to itself, to complement this core set. Briefly:

- Follow designated schedules and rosters, and any restrictions on using an area.
- Sign Check-in and check-out log as arranged by your dorm.
- Keep common spaces clean and clear, especially those meant to get wet or dirty.
- Keep your own spaces clean and tidy. Remind or help others to do so, too.
- There can be surprise inspections, so stay on top of your cleaning!
- Get approval ahead of time from dorm staff, for guests and visitors, even those from other dorms on campus.
- Respect your dorm-mates and residential staff. No disturbances please.

### Schedules and Rosters

- Honor time restrictions such as curfew-time, quiet-time, and lights-out.
- If an area has a tighter time restriction, such as “start no laundry after 8pm”, honor it.
- Participate as assigned on daily, weekly, and other cleaning rosters.
- Honor other rosters when present, such as who may do laundry on a given day.

### Common Spaces

- Clean up after yourself, especially in the kitchens and bathrooms. When convenient, please also clean a little bit more in passing – leave it better than you found it.
- Dress decently outside your room: Pajamas are fine, nudity or underwear are not.
- Food storage in refrigerators should be covered, with your name, and consumed within 5 days.
- Food will be discarded when kept for too long.
- Do not eat food that does not belong to you. If you did not buy it, it is not yours, and you are stealing!
- Keep public areas free of personal items.

- Clean off your shoes before coming into the dorm.

### Your Own Spaces

- Sleep in your own room and in your own bed.
- Make your bed before checking-out for the morning.
- Tidy your desk and workspace before going to bed in the evening.
- Keep dirty laundry contained and covered until you wash it.
- No paint, stickers, posters, or other permanent decorations.
- Do not hang sheets or blankets or other materials around the bed frames making a “tent”.
- If something breaks or otherwise needs maintenance, let dorm staff know, so we can get it corrected for you.

### Inspections

- Inspections of rooms and common areas can happen at any time with/or without prior notice.
- Inspections check, at minimum, for safety hazards, cleanliness, illegal substances, unregistered electronic devices, and anything that is in violation with school rules and policies as well as any potential problems with the dorm room and facilities.
- Correct anything you can, when found.

### Check-in and Check-out

- Follow your dorm’s procedure for checking-in and checking-out for classes and activities, each time you go in or out.
- Sign in/out only yourself, not for others. Let them get into the habit themselves.
- Sign in/out with a timestamp, please, not just a checkmark.

### Guests and Visitors

- Students may not visit the dormitories occupied by those of the opposite gender.
- Visitors need to pre-arrange and seek approval from the Residential Staff/Director.
- Visitation can only take place in the common area of the dorm and not in private bedrooms.
- No visitors are allowed in the dorms after 9PM.
- No overnight guests or visitors are allowed to spend the night in the dormitories.
- The larger the gathering, the more lead-time residential staff want. Ask early, please.

### Local Sleepovers with Homestay or Day Students

- Over time, sleepovers have proven to create significant challenges for the residential program.
- Managing 50–70 residential students makes coordination of multiple off-campus sleepovers impractical.
- Allowing sleepovers requires extensive oversight, including:
  - Contacting parents and confirming permissions.
  - Coordinating and providing transportation.
  - Ensuring proper supervision and adherence to residential standards.
  - Addressing concerns related to smartphone and video game access.
- With the current number of students, maintaining proper oversight for sleepovers would require staffing resources beyond our capacity.
- For this reason, **sleepovers with local homestay or day students are not permitted during the school year.**

- During **winter and summer breaks**, parents may arrange these types of visits directly at their discretion.

## Trips and Transportation

The school organizes scheduled shopping, educational and entertainment trips for dorm students during the weekends. Participation is voluntary. Students should follow the same behavior rules in vehicles as the school requires in classrooms. Please refer to the [School Vans and Bus](#) section in this handbook for the behavior expectations.

### Expectations for trip travel on a bus:

- Respect the driver, and under no circumstances distract the bus driver while driving.
- Students remain seated, hands and body within the bus.
- Voices are quiet and respectful of others, no yelling or loud singing.
- Upon departure from the bus, all rubbish is taken out of the bus and thrown into the trash can.
- Failure to follow these rules present a safety hazard to all passengers. Failure to comply will revoke future trip privileges.

### Respect Those Around You

- Honor others' personal boundaries, e.g. keep your hands to yourself at all times.
- Communicate timely and politely. Tactfully let others know your personal boundaries.
- **NO STEALING.** Get permission before using others' stuff, or eating others' foods. If you did not buy it, it does not belong to you.
- Let the residential staff know promptly when you see an issue that needs to be addressed.
- Don't disturb others:
  - No addictive substances or activities of any kind, such as video games or unpermitted internet use. No smartphones or electronics with browsers and WiFi
  - No noise or music during quiet hours. Nothing loud outside quiet hours.
  - No profane, violent, or vulgar speech or images.
  - No unwanted horseplay.
  - Hazing is illegal, as is sexual harassment. So, don't.
  - If someone tells you to stop or says no, you must stop. Apologize and correct as needed.
- Dress decently and appropriately, even during weekends.
  - No clothing with profanity or violent messages or graphics.
  - No mini shorts/skirts, spaghetti strap tops, or torn/ripped/faded/vulgar clothing.
  - Shorts pants cannot be shorter than mid-thigh
  - Skirts must be on or below the knee. Sit properly and respect yourself.
  - No shorts or swimwear outside in winter. No pajamas outside the dorm.

### Personal Boundaries and Interactions

- All romantic relationships, dating, and physical displays of affection are prohibited.
- Students may not meet with or walk alongside members of the opposite gender during off-campus walks.
- Students may not be alone with the opposite gender in classrooms, on walks, or in any unsupervised area.

### Reporting a problem

- Do report any difficulties you are experiencing to Residential Staff/ Director / SAO; if you are feeling unsafe or someone is bullying or harassing you, don't keep it to yourself - let us know!

- If you see something, say something - we are all responsible for keeping our community safe!
- Should anyone express an intent to hurt themselves or others, take it seriously and tell! It is not okay to keep such information secret - you could save a life!

### Consequences

- Fees and loss of deposits can be levied for cleaning not completed as assigned.
- Damage to furniture and other dorm property, beyond normal wear-and-tear, will be charged at replacement cost.
- Any device, activity, or behavior which causes disturbances may be barred.
- If you break dorm rules too often or too severely, causing trouble for the dorm, you will be given a move-out notice.
- Northern Academy reserves the right to discipline any student who engages in behavior which endangers their own life or who engages in behavior that is a direct threat to the health, safety or lives of others. Such discipline may include suspension and or dismissal from school and dorms.

### Signature and Acknowledgement

All dorming students are required to sign the General Dorm Rules upon arrival.

## Valuables & Pocket Money

It is important for parents/guardians to arrange for their child a means to access pocket money. Many on-campus and off-campus activities require cash for tickets and purchases.

- Establish with your local/international bank a student spending account that will provide a card for your child that is usable in the US.
- Parents/guardians are expected to follow all US banking regulations.
- Dorm students are encouraged to use debit cards to access their pocket money. Use of debit / credit cards must be monitored by parents.
- Passport, wallets, money, account debit or credit cards and items of value should be kept secured. Lockers are available in dorms and students are strongly advised to buy a combination lock to secure the locker. The school takes no responsibility for the loss of valuables on campus.
- To prevent problems from occurring in dorms, students need to be mindful of the following:
  - Do not leave your wallet / money / debit or credit card lying around openly on your desk or bed for others to see.
  - Do not allow others to use your debit or credit card for purchases or share your account information.
  - Do not purchase things for others online using your accounts.
  - Do not ask dorm staff to purchase things for you online.
  - Do not borrow money from staff or other students.
  - Do not lend money to anyone.
  - Show respect to your parents by taking good care of your personal belongings and how you spend the money they give to you.
- Dorm students should limit their pocket cash to \$100 or less to minimize accidental loss.
- Keep a ledger to help you to keep track of your budget and expenditures.
- Respect your parents/guardians, until you are making money yourself, they are the ones supporting you financially. Don't take this for granted.

# VISITORS

- Parents, relatives and friends who do not live in dorms need to pre-arrange and seek approval from the Residential Staff of the dorm for the visit.
- Students are not permitted to visit the dorms of the opposite gender.
- Same gender siblings or relatives who live in another dorm must seek permission to visit their sibling or relative's dorm.
- Visitation can only take place in the common area of the dorm and not in private bedrooms.
- Visitors are not allowed in the dorms after 9PM, and are not allowed to spend the night in the dormitories.

## Off-Campus Travel

Student travel to destinations off campus must have written parental permission submitted no less than 24 hours in advance of the date of activity, via the [Residential - Parent Consent Form for On- and Off-Campus Travel](#)

- Residential staff must be informed of leave as well as the destination, and students are expected to return by curfew (9pm).
- Students who need to be picked up by non-school personnel or spend the night outside of the dorm *must* have the details of the responsible person and contact details provided in the [Residential - Parent Consent Form for On- and Off-Campus Travel](#)
- Parents who fetch their students from the dorm must notify the Residential Staff in advance of the pickup.
- All boarding students, including those 18 and older, must have parent permission for any travel or time off campus. Parents must complete the Residential - Parent Consent Form for On- and Off-Campus Travel (Cognito form) for each request.

Failure to follow these requirements is a serious violation of dorm rules and the NA Discipline Policy. Suspension of privileges, will be decided by the Residential Director and/or residential staff. Examples of this are displayed below:

**Violation 1** - (Example): Student returns after 9pm curfew, or is not where, or with whom, they said they would be.

Consequence: Dorm Rules Violation infraction is entered in FACTS/Renweb, revocation of privilege to leave campus (including weekend trips or shopping) for two weeks. Parents receive notification.

**Violation 2** - Student violates the rules for a second time. Leave is suspended for a month, a second infraction is logged with higher consequences. Parent meeting is arranged by the Residential Director. One more incident may result in dismissal from dorms.

**Violation 3** - The safety and security of our students is a priority. We are not able to be responsible for dorm students who do not respect and follow our boarding rules. The student will

have to move out, and other arrangements made. In addition, such violations impact whether they can remain as a Northern student.

## PHONE & ELECTRONIC DEVICE POLICY

Dorm facilities have a land-line phone for student use. We recommend that students and parents set a scheduled time each day or week so the call is expected. The use of smartphones and internet devices are not allowed on campus (refer to the "[Student Use of Electronics, Devices and Resources](#)" regarding such devices). Should a student possess any unauthorized electronic device that is internet capable, the device will be confiscated and will be returned only on the last day of school at the end of the school year. Only school-issued phones and computers are allowed. Gabb phones and non-internet flip phones without a browser are permissible. Students who travel with a device have the opportunity to register and hand-in the device for safekeeping until the end of the school year. Access to the device will not be allowed.

### Computer Use and Internet Access

In order to allow students sufficient sleep time, dorm internet access is available until 10:30pm Sunday to Thursday, and until 11pm on Friday and Saturday.

All sixth grade through eighth grade students may request to borrow Chromebooks from residential staff for studying, checking emails, or communicating with parents. These Chromebooks will only be available in designated places and times.

#### **Student Use of Electronics, Devices and Resources**

- Nothing intrudes on school hours
- No outside "smart" or "dumb" devices or general-use computers are allowed
  - Nothing Internet-capable, nothing which can connect elsewhere
- Northern-assigned devices, networks, accounts only.
- Northern school phone is available for rent
- Chromebooks issued to high-schoolers, limited in-dorm use for middle-schoolers

#### **Reasons Behind A Strict Policy for Student Use of Electronics, Devices and Resources**

- Enhancing Focus and Self-Discipline: Promote focus, critical thinking, self-awareness, and self-control.
- Responsible Technology Use: Guide students on effective use of technology and understanding the content it provides.
- Essential Life Skills: Prepare students with the necessary skills to navigate the contemporary world.
- Filtering External Influences: Protect students from the unfiltered barrage of others' wants and desires.
- Grounded Reality: Help students stay connected to the real world amidst the distractions of virtual experiences.
- Fostering Personal Growth: Support each student in becoming their best self.

#### **Student's Personal and Academic Growth is Essential**

##### Student Safety and Security

- No social media activities
- "No devices" time for boarding students for sleeping hours - all devices will be collected before the start of lights-out

#### **How Does It Work?**

The Northern Phone is the ONLY on-campus phone or dorm student phone.

- Personal cell phones will be submitted to school upon receiving Northern Phone and will be stored off campus; Personal cell phones will be returned to students when they return home for Summer break.
- \$90 rental for the school year + \$110 security deposit (At the end of the school year, deposit will be returned to exiting students if the phone is maintain in good condition, or be carried-over for next year for returning students)

#### **SIM-Cards**

- Parents/Students are responsible for purchasing SIM-Cards. Options include
- Use existing SIM-Cards from their current phone
- Purchase SIM-Cards and mail to school (under student's name)
- Student purchase SIM-Cards on first weekend shopping trip

#### **Important Notice**

- The use of Northern devices is for education and communication purposes.
- Northern Academy reserves the right to inspect such devices and files stored in such devices at any time.
- Any changes to the setup of the school-issued devices is strictly prohibited.
- Do not share school-assigned devices with others

#### **How can students communicate with parents? Student Safety and Security / Stay Connected with Family is Our Priority**

- Anytime after school until quiet time
- Weekends & Holidays 8am-10pm (NY time)
- Northern School phone -
  - Phone Call and Text
  - Signal App (make video/audio calls via dorm internet)
  - Photo/Video functionality to share your school life with family and friends
  - Facetime via iPad in dorms
  - Skype via Chromebook
  - Computer Lab -(until 8:45 pm) for boarding students (academic work has priority)

#### **How can families support our phone and electronics policy?**

- Do not allow your child to purchase a smartphone on their own.
- Do not buy or allow your child to buy unlimited data plans.

Parents play an important role in upholding the Northern mission and values. Everyone contributes their part to keep our community moving upward.

## **DISCIPLINE**

The dormitory is an extension of the school. All rules and policies as described in the [Northern Academy Discipline Policy](#) also apply to the dorms. Everyone has the right to study, work, play and live in a safe and peaceful environment free of harassment and intimidation. Everyone is responsible to do their part to uphold our values and safeguard our community and environment. If you see something, say something.

- Students who violate dormitory rules may receive demerit points, perform extra duties, lose privileges, be removed from the dorm (Exhibit C, see below), and/or be suspended from the school.
- Possession of controlled substances such as drugs, (which can include OTC and prescription medicines purchased without expressed written permission by parent and health care provider),

illegal drugs (marijuana, THC/CBD, etc.), alcohol (including wine coolers and hard cider), or weapons may result in immediate expulsion from the dormitory and school.

- Use of all tobacco products, including vapes and vape products, are prohibited.
- Possessing, making, sharing pornography or pornographic materials is prohibited.
- All acts of intimacy, public displays of affection and dating are prohibited.
- Sexual harassment, which includes unwanted touch, stalking, unwelcome verbal, nonverbal, or physical conduct of a sexual nature that is severe, pervasive, or objectively offensive, and that interferes with or limits a person's ability to participate in or benefit from an educational program or activity is illegal as defined by Title IX US Federal Law and is prohibited everywhere on and off the Northern campus.
- Bullying, intimidation, hazing and retaliatory acts against those who report are prohibited.
- Damaging the property of others (student, staff, school property) is vandalism and is prohibited, and will incur repair or replacement costs.
- Theft of the property of others (student, staff, school property) is prohibited and will result in disciplinary action and will incur replacement costs. This includes food, drinks and snacks.
- Residential staff have the right to enter and inspect students' bedrooms, and may check students' bags (backpack, pocketbook, shopping bags, lockers, luggages, etc.) at any time.

Violations of any of the above can result in disciplinary action up to and including expulsion and from Northern Academy. Acts that violate local, state or federal laws will be reported to law enforcement and violators may be subject to arrest. Please consult the Northern Academy Discipline Comprehensive review of our policy

## EXHIBIT A. PACKING CHECKLIST

### What to Bring and What to leave at home.

Northern is located in the Northeast of the United States in a mountainous region. Our campus experiences long seasons of cold weather. Snow and cold temperatures are common from November through April. While all dorms and classrooms are heated, students go outside when they transition from dorm to classes. Throughout the school day, students will walk from building to building. Warm clothing and dressing in multiple layers is essential. Purchasing long thermal underwear as a layer under uniforms and casual clothing is strongly advised. Sweaters, knit hats, gloves, scarves, are all necessities for the long cold weather season. Flannel or fleece pajamas with long sleeves and long pants is recommended for sleeping comfortably during cold nights.

#### **Tip 1:**

**Clearly label** all items with the **student's first and last name**. Unlabeled items that are found in common areas and classrooms will be placed in lost-and-found boxes. Unclaimed items will be discarded or donated to the needy.

#### **Tip 2:**

Limit luggage to essential items. Only bring 3 suitcases; dorm bedroom closets are very small.

Northern only provides toilet paper, paper hand towels and hand soap in bathrooms. Personal toiletries and self-care items, snacks, and general school supplies can be purchased locally during scheduled weekend shopping trips.

**Dormitory Beds:**

Dormitory beds are bunk-beds, and include a “Twin” sized mattress.

**Bedding for beds is not provided by the school and can be purchased locally:**

- Twin sheets, fitted and flat - 2 sets
- Mattress cover/padding *\*optional*
- Blanket
- Pillows
- Bedspread, comforter

# EXHIBIT B. Change of Residential Status

## From Residential to Day/Homestay

Note: To ensure a smooth start to the semester and maintain a stable environment for all students, we have a non-refundable boarding fee policy effective at the beginning of each semester. Please be aware that if you withdraw your child from the school dormitory during the semester, the boarding fee is non-refundable.

To move OUT from Residential during the school year, adhere to the following transfer procedures:

**1. Notification**

Parents/Legal Guardian: Inform the [admissions office](#) via email about your child's intention to move out. A minimum of two weeks notice is required.

**2. Approval Confirmation for Move-Out**

Parents/Legal Guardian: Once dues are cleared, notify both the admissions and tuition offices via email, confirming your approval and acknowledgment of your child's departure from the dorms.

**3. Paperwork for Move-Out**

Parents/Legal Guardian: Upon receiving the approval email, the admissions office will send you an updated residential contract & agreement form. Additionally, if your child is moving in with a host family, please complete the Temporary Guardianship Appointment Form.

**4. Paperwork Submission**

Parents/Legal Guardian: Sign and send back your child's updated residential contract & agreement form. If applicable, include the completed and notarized Temporary Guardianship Appointment Form.

**5. Room Inspection**

Student: Schedule a room inspection with the Residential Director or residential staff and settle any outstanding dues for potential damages to school property before moving out.

**6. Move-Out Coordination**

Upon receiving the required form(s), the Residential Director will schedule an official move-out date for your child. All personal belongings and property must be removed from the dorm on the scheduled move-out date. Any belongings not removed will be considered as abandoned and discarded. Room must and furniture must be clean and in good condition; floor broom swept. Any need for cleanup of the room by Residential Staff will incur a cleaning fee billable to parents.

## From Day/Homestay to Residential

To Move IN to Residential, follow the steps in this process:

**1. Initial Inquiry**

Parents/Legal Guardian: Begin the process by reaching out to the [admissions office](#) to inquire about dormitory availability.

**2. Interview Scheduling**

Student: Schedule an interview with the Residential Director and relevant dormitory staff.

**3. Approval Confirmation**

Parents/Legal Guardian: Upon approval, the Residential Director will send an email to both the admissions and tuition offices confirming your acknowledgement and approval of your child's move into the dormitory.

**4. Paperwork Process**

Parents/Legal Guardian: Upon receiving the approval email, the admissions office will send you an updated residential contract & agreement form.

**5. Contract Signing**

Parents/Legal Guardian: Sign and return your child's updated residential contract & agreement form.

**6. Move-In Coordination**

Parents/Legal Guardian & Student: After receiving the completed residential contract, the Residential Director will coordinate an official move-in date with your child.

## EXHIBIT C. EMERGENCY PLACEMENT

If the school needs to remove a boarding student from the dormitory due to an emergency such as medical or disciplinary issues, it is the parents' responsibility to find their child a new accommodation. An administrative review will be conducted regarding the circumstances.

### **Cost, Payment and Refund**

- The parents are financially responsible for the cost of finding a new accommodation and/or travel expenses.
- Parents are advised to discuss arrangements directly with the owners of the new accommodation regarding fees and payment, the student's schedule, meal plan, transportation, activity and other special needs as well as any expected responsibilities required on the part of the student.
- Fees for the services the school provides during the emergency placement, such as administrative costs, boarding premium, meals, transportation, activities and trips will not be refunded.

### **New Host Family Responsibilities**

- The new host family will assume the responsibilities of a caretaker for the student, which includes transportation, taking care of the student during sickness, and meeting the daily living needs.
- The hosting family may not make decisions regarding the student's education or non-emergency medical conditions, which are still the responsibility of the parents.
- School communications will be directed to the parent.
- All parties (school, host family, parent(s)) should work cooperatively for the well being of the student.
